## ABOUT THE COURSE *cont.*

### **Module 1: Professional Development (29 credits)**

Involves the collection of evidence of the learner's professional development and ability to work in the field as a professional environmental practitioner.

### **Module 2: Understanding Environmental-People Relationships (26 Credits)**

This module addresses human impact on our natural and built environment and explores the ways in which individuals, society, nations and international institutions can actively contribute towards sustainability.

### **Module 3: Environmental Ethics (13 credits)**

The module covers understanding perceptions and developing an ethical code of conduct for the environment. The learning creates an awareness of how our notions of "right" and "wrong" are formed, how we become more aware of conscious of our own values and beliefs and how these lead to what we do and how we behave in this world. We look at the field of environmental ethics and learn the language that helps us to talk about this complicated field in more depth.

### **Module 4: Develop an Environmental Learning Programme (DELP) (26 Credits)**

A wide range of educational resources and materials are investigated to assist in the learner being able to develop tools and resources for learning.

### **Module 5: Facilitate & evaluate an Environmental Learner Programme (FEELP) (28 Credits)**

Investigate a wide range of methods and approaches to teaching and learning. Hands-on, practical skills to implement and assess environmental learning programmes.
